



Pushing tube in before pulling it out helps to release tube




NOTE : Waterflow direction




**INSTALLER PLEASE NOTE :**

The grounding of electrical equipment such as telephone, computers, etc., to water lines is a common procedure. This grounding may be in the building or may occur away from the building. This grounding can cause electrical feedback into a water cooler, creating an electrolysis which causes a metallic taste or causes an increase in the metal content of the water. This condition is avoidable by using the proper materials as indicated below. To minimize electrically induced corrosion, all water coolers should be connected to the water supply using an electrically isolating coupling. This cooler is furnished with non-metallic filter which meets this requirement. The drain fittings which are provided by the installer should also be plastic to electrically isolate the cooler from the building plumbing system.
